**Sub: Online Counselling Process of PMSSS Students of the Union Territories of Jammu & Kashmir and Ladakh during Academic Year 2020-2021.**

Sir / Madam,

The matter relates to the online counselling process under PMSSS for the students of UTs of J&K and Ladakh during Academic Year 2020-21.

In this context, it is informed that the AICTE is likely to conduct online counselling for aspiring students who have registered themselves on AICTE Portal and have been declared eligible under the Scheme by J&K and Ladakh Govt. during end of October, 2020. The meritorious students may be issued allotment letter with a copy to Principal / Nodal Officer of the respective institute /Govt. of UTs as per the choice of the students on 30<sup>th</sup> October, 2020.

In view of COVID-19 Pandemic, the students who will be allotted seats during current academic session may not be able to join the institutions physically due to the non-availability of transport facilities and other preventive measures taken by the Ministry of Home Affairs, Govt. of India from time to time. It is, therefore, decided that the allotted student(s) under the Scheme may be permitted to join the respective institute through online mode. The institute will also complete all the admission formalities of the student and verification on AICTE Portal online within the prescribed date as mentioned in the allotment letter.
